1. PROJECT

Choreography and management of cultural performances during ITB 2018, Ref Iulaan: (IUL)MMPRC/1/2018/9 dated 11th February 2018.

2. BACKGROUND AND OBJECTIVES

Internationale Tourismus-Borse/Inetranationa Tourism Exchange ITB Fair held in Berlin, Germany from 7-11 March 2018 is the biggest international tourism event that takes place in the world. ITB Berlin is the biggest tourism event that Maldives also participates in a bigger scale. Hence, in order to make the participation of Maldives in ITB Berlin a success, every year we present Maldivian dance in the stand and as well during the Maldivian Night.

In this regard, to choreograph the dances a Choreographer will be selected to undertake the project for MMPRC.

3. SCOPE OF WORK

- 3.1 The choreographer is to prepare potential performers for an audition by which the final number of 5 performers to perform at ITB will be determined. This audition is to take place within <u>7 working days of awarding the project</u>.
- 3.2 Manage and train the selected 5 performers to represent the Maldives at ITB Berlin 2018 fair according to instructions from MMPRC.
- 3.3 Should choreograph 2 or 3 dances to 2 or 3 songs. Songs should be approved by MMPRC before choreographing the dance.
- 3.4 All related aspects of the performances including costume, props, etc. should be designed by the choreographer. The costumes and props to be approved by MMPRC.
- 3.5 Responsibility of managing the performers during the event according to the instruction of MMPRC officials.
- 3.6 Performers selection criteria: Performers will be selected based on the following;
 - Female performers above 18 years of age
 - Performers of equal height
 - Should be able to speak in English
 - Destination Knowledge
 - Movement sync and Charisma
 - Physically/medically fit
 - Clear police record

4. ELIGIBILITY CRITERIA

- An individual or a company
- Choreographer must have artistic ability to create new and interesting dance routines showcasing the cultural dance moves of the Maldives.
- Should be able to speak in English
- Maldivian national







5. SUBMISSION DOCUMENTS

- 5.1 Cover letter
- 5.2 Bio-data along with a copy of the National Identity Card or Company Profile along with the Registration Certificate
- 5.3 Proof of past experience along with reference letters
- 5.4 Budgetary inclusions: cost break down if there is any fee charged from MMPRC
- 5.5 Details of proposed items (type of item, music, proposed, costume, title and its significance in portraying Maldivian culture)

Note: Police records must be clear and winning party should submit the records within 07 working days after the approval of the performers.

- 6.3 Internal transport in Berlin for official purpose

 - 7.1.2 <u>PROPOSED PERFORMERS PROFILE (10 MARKS):</u> Choreographer should submit profile of proposed performers.
 - 7.1.3 PERFORMANCE DETAILS (30 MARKS): Details of proposed dances.
 - 7.1.3.1 Type of dance and the music/song used (10 Marks)
 - 7.1.3.2 Proposed costume and props (10 Marks)
 - 7.1.3.3 Title and its significance in portraying Maldivian culture (10 Marks)
