1. PROJECT

2. BACKGROUND AND OBJECTIVES

 - 8.2.3.1 Profile of the members (0.5 marks for each member)
 - 8.2.3.2 Copy of national ID (0.5 marks for each member)
 - 8.2.3.3 Instrument played (0.5 marks for each member)
 - 8.2.3.4 Past experience of the members (1.5 marks for each member)
 - 8.2.3.4.1 0 to 5years (0.5 marks)
 - 8.2.3.4.2 6 to 10 years (1 mark)
 - 8.2.3.4.3 More than 10 years (1.5 marks)

- 8.4.2 **<u>REPERTOIR OF SONGS (05 MARKS):</u>** The bidder should submit a list of songs (minimum 50 songs) that will be played during ITB Maldivian Night. This should include, Dhivehi, English, German.
 - 8.4.2.1 If the song list consist of only Dhivehi and English songs 4 marks will be awarded.
 - 8.4.2.2 If the song list consists of Dhivehi, English and German songs 5 marks will be awarded.







8.4.3 <u>MUSIC (05 MARKS):</u> The bidder should also include the type of performance they will give.

8.4.3.1 05 marks will be awarded for live performance.

8.4.3.2 If the party does not state whether it is a live or karaoke performance 0 marks will be awarded.
