INFORMATION SHEET RENTING OFFICE SPACE

1) **BACKGROUND:**

Maldives Marketing and Public Relations Corporation (MMPRC) is looking for a party to rent a space for office setup as per the requirements of MMPRC.

2) **REQUIREMENTS:**

- i. Area/ Floor size in Sq Ft. (2,500 to 3,000 SQFT)
- ii. Identity Card of the Owner & proof document. (Premises Registry).
- iii. If the building is owned by a company, should submit company registration certificate along with GST certificate.
- iv. High marks will be given to space from Prime Location
- v. Easy Access to the building
- vi. Before the space is handed over it should be cleaned and painted.
- vii. All parties should submit relevant and valid documents to support the above criteria.
- 3) GUIDLINES FOR SUBMISSION OF PROPOSALS:
- i. Each submission should include the following:
 - i) If it is from a company, Company Profile, Registration Certificate, Building Registration Certificate and Tax Registration Certificate:

A company profile with details of organizational capacity and previous works/awards should be submitted along with the bids. In addition to these documents, <u>a copy of company registration certificate</u>, <u>building</u> registration certificate and tax registration certificate should also be submitted.









ii) <u>If it is from an individual party, CV, Building Registration Certificate</u> <u>and Tax Registration Certificate:</u>

An individual party should submit these documents, <u>a copy of</u> <u>Curriculum Vitae</u>, <u>Identity Card</u>, <u>building registration certificate and</u> <u>tax registration certificate should also be submitted</u>.

iii) <u>Budget</u>

Submit your proposals along with proposed budget in details for the project. Proposal should also include a suggested payment schedule and the rationale/deliverables behind it.

Marks will not be awarded for respective categories for the bids that are received with incomplete information.

4) EVALUATION CRITERIA:

i. BUDGET (40 MARKS):

- i) Monthly Price (30 marks)
- ii) Advance Payment (10 marks)

ii. LOCATION (30 MARKS):

i) Maximum marks will be awarded for prime locations

iii. SIZE (15 MARKS):

i) Marks will be awarded on pro rata basis.

iv. FACILITIES (10 MARKS)

- i) Minimum two separate toilets
- ii) Availability of Lift/Service Lift
- iii) Balcony space
- iv) Security System such as CCTV, etc









v. DURATION (5 MARKS)

i) Prefer short terms renting (3 to 5 years)

5) <u>REQUIRED DOCUMENTS</u>

- i. Copy of Building Registration Certificate along with Owner's National Identity Card copy or Company Registration Certificate along with Tax Registration Certificate
- ii. Floor Plan of the building or floor
- **iii.** If the bidder is subletting the building or floor, letter of permission from the owner shall be submitted
- iv. Details of the available facilities of the building
- v. Cost Breakdown
