# INFORMATION SHEET RENTING OFFICE SPACE

## 1. BACKGROUND:

Maldives Marketing and Public Relations Corporation (MMPRC) is looking for a party to rent a space for office setup as per the requirements of MMPRC.

#### 2. **REQUIREMENTS:**

- 2.1. Area/ Floor size in Sq Ft. (minimum 3,000 SQFT)
- 2.2. Prime Location
- 2.3. Easy Access to the building
- 2.4. Minimum 02 toilets
- 2.5. The office space should be cleaned and painted before it is handed over to MMPRC
- 2.6. All parties should submit relevant and valid documents to support the above criteria.
- 2.7. Space should be handed over to MMPRC in the above mentioned conditions within 03 months of signing of the contract.

- 3.1.1.5. Building Floor Plan
- 3.1.1.6. If the bidder is subletting the building or floor, letter of permission from the building owner for the contract period.
- 3.1.1.7. Details of the available facilities









# 3.2. If an individual party:

- 3.2.1. Individual's national ID card copy
- 3.2.2. Building Registration
- 3.2.3. Building Floor Plan
- 3.2.4. If the bidder is subletting the building or floor, letter of permission from the building owner for the contract period.
- 3.2.5. Details of the available facilities

## 3.3. Advance and Rent

Submit the proposal along with the advance and rent payment amount and terms for renting the space. This should include a suggested payment schedule.

Marks will not be awarded for respective categories for the bids that are received with incomplete information.

- 4.1.2. Advance Payment (10 marks)

# 4.2. LOCATION (30 MARKS):


4.2.1. Maximum marks will be awarded for prime locations

# 4.3.SIZE (15 MARKS):

4.3.1. Marks will be awarded on pro rata basis on the floor space area

#### 4.4. FACILITIES (10 MARKS)

- 4.4.1. Minimum two separate toilets (4 marks)
- 4.4.2. Availability of Lift/Service Lift (3 marks)
- 4.4.3. Security System such as CCTV, etc. (3 marks)









## 4.5. RENT PERIOD (5 MARKS)

4.5.1. Prefer short term renting (3 to 5 years)
